

### Christmas Bonus

Social Welfare recipients will receive a bonus payment in early December. The bonus is equivalent to 100% of the normal weekly payment. In other words a lone parent with one child in receipt of the maximum rate of one parent family payment will receive an additional €221.80 in December.



## CSO Statistics - Yearly Summary 2007

There were 70,620 births registered in 2007. There were 23,170 births registered as outside marriage in 2007. This accounted for 32.8% of all births, a decrease of 0.4% on 2006. The highest percentage of births outside marriage occurred in Limerick City at 55%, while the lowest percentage was in Galway County at 21%. A total of 2,251 unmarried teenagers had babies in 2007. This accounted for 9.7% of all births outside marriage in 2007.

## BUDGET 2009

### Child Benefit

From January 2009 Child Benefit for 18 year olds will be €83. Payment of Child Benefit for 18 years olds will cease altogether from 2010.

Special alleviating measures are being introduced to compensate for this. Families on Social Welfare payments will receive an additional €15 per week in the Qualified Child Payment for children aged 18. Compensatory measures will also be applied, where appropriate, to Family Income Supplement and the Back to School Clothing and Footwear Allowance Scheme in respect of 18 year olds. These arrangements will apply until 2011.

There will be no increase in Child Benefit in 2009.

### One-Parent Family Payment (OFP)

In January 2009 the weekly personal rate of OFP increases by €6.50 to €204.30. The weekly qualified child rate increases by €2 to €26. The maximum rate of OFP for a parent with one child will be €230.30 per week.

***As outlined above there will be a special increase in the case of a qualifying child of 18 years of age. The total rate for a qualified child of 18 will come to €41(€26+€15) per week which includes the special payment of €15 in lieu of the reduction in Child Benefit.***

In January 2011 this increased rate will cease to apply.

### Family Income Supplement (FIS)

From January 2009 the Family Income Supplement weekly income threshold will increase by €10 per week per child.

#### Family Size Income Limit

1 child	€500
2 children	€590
3 children	€685

***An additional payment of €15 per week will be paid where appropriate in respect of an 18 year old child to a family who qualifies for FIS. This arrangement will apply until January 2011.***

### **Back to School Clothing and Footwear Allowance**

From June 2009 the additional income disregard to qualify for the Back to School Clothing and Footwear Allowance will be increased by €50 per week from €100 to €150

***The Back to School Clothing and Footwear Allowance will be increased by €215 to €520 per annum for a qualified child aged 18 from June 2009.***

This transitional payment will cease in January 2011.

### **Early Childcare Supplement**

From 2009 the Early Childcare Supplement will be paid for children up to the age of five and a half. It will no longer be payable up to the age of six.

This will become a monthly payment (€92 per eligible child) instead of quarterly.

### **Maternity Benefit**

The minimum rate of Maternity Benefit will be increased by €8.50 per week to €230.30 per week from January 2009.

### **Fuel Allowance**

The Fuel Allowance will increase by €2 to €20 per week from April 2009. The number of weeks covered by the fuel allowance is to be extended by 2 weeks to 32 weeks from April next year.

### **Rent /Mortgage Interest Supplement**

From January 2009 the minimum contribution for people in receipt of Rent Supplement or Mortgage Interest Supplement will increase from €13 to €18 per week.

### **Income Tax**

The Standard Single Rate Tax Band will increase by €1,000 for a single person to €36,400. There will be no changes in Tax Credits.

### **Income Levy**

There will be a new income levy effective from 1 January 2009. The levy will apply at the rate of 1% to gross income up to €100,000 per year. This levy will not apply to incomes up to the level of the national minimum wage.
